

ORDINANCE NO. 43

AN ORDINANCE OF THE SAN SIMEON ACRES COMMUNITY SERVICES DISTRICT FIXING THE AMOUNT OF MONEY NECESSARY TO BE RAISED BY TAXATION FOR THE CURRENT FISCAL YEAR BEGINNING JULY 1, 1973, AND FIXING THE RATE OF TAXES FOR SUCH FISCAL YEAR.

BE IT ORDAINED by the Board of Directors of the San Simeon Acres Community Services District as follows:

1. The amount of money necessary to be raised by taxation upon the taxable property within the San Simeon Acres Community Services District as revenue to carry on the various departments is hereby fixed as the sum of \$ 21,834.00 .

2. For the purpose of raising said sum of money necessary to be raised by taxation upon the taxable property within said District as revenue to carry on the various departments of said District for the fiscal year beginning July 1, 1973, the rate of taxes is hereby fixed and taxes are hereby levied on all taxable property within said District for the fiscal year beginning July 1, 1973, at the rate of \$ 2.26 upon each \$100.00 of the assessed valuation of said property as assessed by the Assessor of the County of San Luis Obispo, State of California, and equalized by the Board of Supervisors of said County, of which \$ 1.26 per \$100.00 valuation is to apply to Bond Interest and Redemption Fund, and \$ 1.00 per \$100.00 valuation is to apply to General Fund.

3. This Ordinance is passed and adopted pursuant to the provisions of an Act of the State of California, known as the Community Services District Law (Government Code, Sections 61000, et seq.).

4. This Ordinance, within fifteen days after its passage shall be published at least once in a newspaper of general circulation in the County of San Luis Obispo.




