#### WATER METER BOXES

Please do not place items on top of the meter boxes/lids or allow overgrowth of plants to cover the meter boxes. These items/plants must be removed by District Staff to read the meter. Also, if you have plants or shrubs that approach or cover fire hydrants, these plants will be cut back.

Vehicles and Recreational Vehicles/Trailers SSCSD Ordinance 107 identifies restrictions and enforcement related to parking vehicles on streets for more than 72 hours, broken down vehicles for 2 hours, sleeping in vehicles and parking of recreational vehicles. If you have friends or family planning to visit San Simeon with their RV or camper trailer, please contact the SSCSD office to obtain a permit. SSCSD Ordinance 107 details the RV parking permit requirements. We ask hotels that have patrons with RVs to park on hotel property or obtain a parking permit from the SSCSD if street parking is necessary. Please inform SSCSD whenever you see an RV on District streets that does not have a pink parking permit in the window. The permit should appear on the driver's side window.

# **FLAG ETIQUETTE**

The Flag Code, which formalizes and unifies the traditional ways in which we give respect to the flag, also contains specific instructions on how the flag is not to be used. They are:

 The flag should never be dipped to any person or thing. It is flown upside down only as a distress signal. drapery, or for covering a speaker's desk, draping a platform, or for any decoration in general. Bunting of blue, white and red stripes is available for these purposes. The blue stripe of the bunting should be on the top.

- The flag should never be used for any advertising purpose.
- The flag should not be used as part of a costume or athletic uniform, except that a flag patch may be used on the uniform of military personnel, fireman, policeman and members of patriotic organizations.
- The flag should never have placed on it, or attached to it, any mark, insignia, letter, word, number, figure, or drawing of any kind.
- The flag should never be used as a receptacle for receiving, holding, carrying, or delivering anything.
- When the flag is lowered, no part of it should touch the ground or any other object; it should be received by waiting hands and arms. To store the flag it should be folded neatly and ceremoniously.
- The flag should be cleaned and mended when necessary.
- When a flag is so worn it is no longer fit to serve as a symbol of our country, it should be destroyed by burning in a dignified manner.
